### RESOLUTION

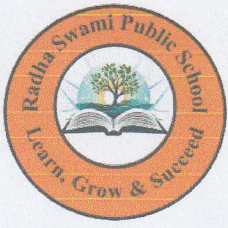
It is hereby resolved that:

That the school shall maintain all necessary records and documents as required by CBSE and produce the same whenever required.

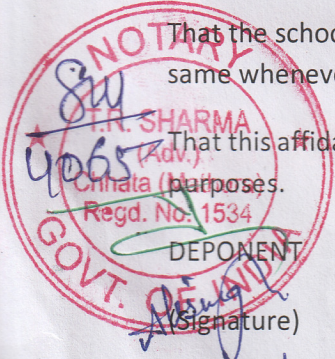
